Conclusion

There are objections to the proposed development in its current form, and should a formal application be made, the Council would be unlikely to support the development.

There are concerns regarding:

- The design of the proposed development impacting the character and appearance of the existing pair of semi-detached properties and surrounding area as well as infilling a spacious gap within the street scene.
- The design of the external amenity area for both the new dwelling and retained dwelling due to the existing outbuilding structure.
- Insufficient information has been presented to determine the impact of the proposed development on the bungalow properties at numbers 44,46 and 48 The Larches. Any future application should be accompanied with a sunlight and daylight assessment.
- There would be highway objections in its current form due to the overprovision of car parking spaces, pedestrian access and the location of the cycle spaces.
