During our meeting, Becky advised that she was not opposed to the additional extension to the side of the property but had mentioned about whether the conservation officer would support it. We discussed a fallback option of an outbuilding to the side of the house, providing the same amount of required habitable space as the extension which could be gained under permitted development. This option has now been illustrated on the plans we've submitted.

Becky's written response to the original pre-application scheme, following the meeting, was as follows:

"The proposed single storey side extension would not accord with Policy DMHD 1 and would result in harm to the character and appearance of the historic building within the Conservation Area."

"Any forthcoming application would need to address this harm given that there are no public benefits to outweigh the identified harm, and provide a Tree Survey / Arboricultural Impact Assessment."
