Extend existing kitchen into part of the existing garage.

The original attached side elevation garage was (some years ago - date unknown) demolished and a new garage constructed running virtually the full depth of the house. Above the garage a 1st floor bedroom was also constructed this running approximately to half the depth of the house. The applicant now wants to extend into the garage to extend his kitchen.

The work will involve raising the existing garage flat roof to a height so ceiling levels in the new space are equal to those in the existing house. Existing foul and surface water drains will be utilized in this development but essentially the underground drainage will be unaffected.

There is no extension to the existing footprint of the building. The only expansion of volume would be to raise the roof of part of the existing garage where it will become the extended kitchen. This raising of the roof does not exceed 4.0 from outside ground level.
