Conclusion

In its current form, the Local Planning Authority would not support the proposal.

The applicant has positively responded to feedback received during the pre-application process, and the amendments are supported; however, due to the loss of the existing chimney, the proposal would unduly harm the character and appearance of the building and ASLC.

Further, no information has been provided regarding the proposed front landscaping of the site, which must be provided in a future full application for the Local Planning Authority to assess the effect of the proposal on the streetscape and the character of the ASLC.

The proposal would deliver an acceptable level of onsite residential amenity for future occupiers, and amendments have been submitted, reducing the bulk of the proposal. The amended scheme, with the proposed flank windows changed to opaque glazing, would not unduly impact the residential amenity of neighbouring properties and would be supported in this regard.

The applicant's future planning application must be supported by a Tree Survey and Arboricultural Impact Assessment prepared by a qualified arboriculturist to demonstrate compliance with Policy G7 of the London Plan (2021) and Policy DMHB 14 of the Hillingdon Local Plan: Part Two (2020).

It is anticipated that the Local Planning Authority could support a revised full application with appropriate amendments and additional information in line with the above advice.
